

# Appliance Rebate



## Terms & Conditions

The Power Forward residential rebate program is provided by Heartland Energy in collaboration with the City of Madison. **Incentives are provided to residential customers for replacement or new appliances with a new ENERGY STAR model.**

- Residential customers of the City of Madison are served by Heartland Energy and are eligible for rebates.
- Rebates are only available on ENERGY STAR products purchased as outlined in this application and purchased and applied for in the current calendar year. Applications must be submitted by December 31, 2024.
- Rebates are available on a first-come, first-served basis and are subject to eligibility and availability of funds. This program is subject to change or termination without notice.
- Each account is eligible to receive one rebate per appliance type. Application must be filled out completely in order to be considered.
- A copy of proof of purchase/sales receipt along with ENERGY STAR verification must be included and will not be returned. Verification of disposal (replacement only) is required for refrigerator and freezer rebates.
- Rebates will be issued by the City of Madison. Please allow up to 90 days for delivery of rebates.

# Power Forward Residential ENERGY STAR Rebates
